SUPPLEMENTARY REGULATIONS

The Woolbridge Motor Club Ltd. will organise a Clubmans Car Trial on **Sunday 14th January 2018** at Hog Cliff, map ref 194 / 615974. The venue is approached from the A37 Dorchester – Yeovil road – Approx. 3 miles south of Clay Pigeon Kart circuit.

1. Held under the General Regulations of the Motor Sports Association Ltd (incorporating the provisions of the International Sporting Code of the FIA), these supplementary regulations and any written instructions the organising club may issue for the event.

2. MSA permit number – **TBA**

3. The event is a round of the Woolbridge Motor Club Ltd Car Trials Championship and is open to all fully elected members of Woolbridge Motor Club Ltd and members of

5. There will be at least 6 sections wholly on private land and at least four runs will be allowed at each section.

The entry may be split into groups to facilitate completion of the event.

6. The programme is as follows: - Scrutineering starts at 0900 hrs. First test at 1000hrs. Any competitor not signed on by 20 minutes before the start time may be excluded.-

7. All vehicles must comply with MSA Technical Regulations, section T11 to T11.14.4.

5	Class 5 4WD PRODUCTION CARS – NOT ELIGIBLE FOR INDEX OR CHAMPIONSHIP POINTS Four wheel drive Production Cars of monocoque construction, taxed for road use, carrying no ballast, unmodified, and driven to the venue. Where fitted with a dual range transmission, only high range may be used. Competitors are reminded of the requirements of section T11.9. The original carburettors or fuel injection system including the throttle body and plenum chamber, including the air filter system, must be retained. It is permitted to replace the air filter element within the original housing.	4WD	Any	TBC
6	Class 6 CARS NOT ELIGIBLE FOR CLASSES 1 TO 5 - NOT ELIGIBLE FOR INDEX OR CHAMPIONSHIP POINTS - and only eligible for a Class award (subject to 3 in the class) Fiddle brakes are acceptable for this event	RWD	Any	Free

Note 1 – any car fitted with a torque biasing differential or any other form of traction control as catalogued for that car will have tyre pressures set at 4 psi above the relevant class pressure.

Note 2 – cars with an overall length of 166 inches and over in classes 1 and 2 may reduce tyre pressures by not more than 4 psi subject to an absolute minimum pressure of 12 psi.

Note 3 – The organisers may include sections which are timed, have split routes, have different starts, have restart sections or other tests of a similar nature.

8. Awards will be presented as follows: -

- i. **The Hogcliff Trophy** (to be retained for 11 months) + replica – awarded to the Best Performance Overall (calculated on index of performance)
- ii. Best Performance by a WMC entered competitor (calculated on index of performance, not awarded if 1st Overall is a WMC entrant)
- iii. Best performance in each class
- iv. Second best performance in each class, subject to 5 or more starters
- v. Third best performance in each class, subject to 9 or more starters
- vi. Best performance by a Novice i.e. – a competitor who has not previously won an award on a car trial, subject to 3 starters (calculated on index of performance)
- vii. Under 23 award, awarded to best competitor under 23 years of age (calculated on index of performance)
- viii. Best lady driver. (calculated on index of performance)
- ix **No competitor may receive more than one award except the title Trophy.**

The order of priority for awards is as above. Eg. 3rd in class is higher than the novice or U23 award

9. The maximum entry for the event is 40. The minimum for each class is 3. Should any of the minimum figures not be reached, the organisers reserve the right to cancel the meeting or amalgamate classes. The entry list opens with the publication of these regulations and closes on the **Wednesday** before the event.

The entry fee is £20.00. (Under 23's - £5) All entries must be made on the official form and be accompanied by the entry fee. **NO ENTRIES WILL BE ACCEPTED ON THE DAY**

Any entry received after the closing date will secure a £5 penalty charge.

12. All other General Regulations of the MSA apply as written

13. No practising or unnecessary movement of cars will be allowed. Once a competitor's front wheels have crossed the start line of an observed section he / she will be deemed to have started the section.

14. No car may have more than three drivers – and then only by express permission of the Organisers before the event.

15. Competition cars, except Class 1, need not have a current Road Fund Licence or MOT if required as the event is on private land.

16. It is a competitor's responsibility to return score cards to the secretary of the meeting after each round.

17. In line with MSA regulations, passengers in car trials are **not** mandatory. However, if a competitor starts the event with a passenger he must retain the passenger for the event and vice versa.

The seat alongside the driver, if occupied must comply with the following

- a. 12 years of age if the driver is over 17 years of age.
- b. 17 years of age and a competitor in the event, holding a valid non-provisional RTA licence, if the driver is over 16 years of age.
- c. 16 years of age if carried in an open vehicle when an observed section is being attempted. The vehicle's rear seats may be occupied by persons of 2 years or more with appropriate seating arrangements for their age and height

It is the competitor's responsibility to provide such persons before the event.

E-entry form instructions

1. This isn't a true on-line entry system, but is a halfway house that costs nothing and is being used by other clubs around the country.
2. You need access to your own internet banking, and have Adobe Reader 8 or later versions installed on your computer.
3. WMC bank charges are cheaper for e-payments; you may find your own bank charges are less than they are for cheques and you save 50p on a stamp or the cost of driving somewhere to deliver by hand.
4. No compulsion, you can print it as usual and send it in with a cheque.
5. Save the entry form to a suitable location on your computer. You may have to double-click on the attachment or right-click and 'Save as ...'.
6. Open the document. Click on the box next to 'Driver's name' (depending on your settings it may or may not show as a defined box) and type your name.
7. Use the 'Tab' key to move through the boxes (or click on them in turn), completing them as appropriate. You can leave address lines blank if not required.
8. The 'Class' and some other boxes have drop-down menus so just select the one you require from the list.
Refer to the supplementary regulation for full details of the classes.
9. Tick the 'Entry fee' box and the declaration boxes, and the membership boxes if necessary.
10. Save the document when you have completed it. Attach it to an e-mail and send to:-

11. Log in to your bank and make a payment to Woolbridge Motor Club Ltd. The Sort Code is 60-07-01 and the Account Number is 58595376. The amount will be the entry fee of £20 plus, if required, £15 membership and £2.50 for each family member at the same address (only one magazine per household).
12. When making e-payments, there is usually a text box for details of the payment. Please enter 'Trial Oct' (or whatever month for future events).
