The Woolbridge Motor Club Ltd will promote an INTERCLUB Hillclimb on Saturday 27th April 2024 and Sunday 28th April 2024 at Wiscombe Park, Devon. Motorsport UK Permit Number 134572 has been issued.

The events are open to all fully elected members of the promoting club, clubs belonging to the ASWMC, ACSMC and members of the BARC Connaught Speed Championship, SDMC Speed League, Morgan Sports Car Club, Classic Marques Sports Car Club, MX5 Challenge, WAMC Welsh Association, Woolbridge Motor Club Speed Championship, Gilbern Owners Club, Hillclimb and Sprint Association Championship and DEWS Speed Series holding the relevant Competition Licence issued by Motorsport UK. Club Membership Cards, Competition Licences and, where appropriate, Championship Registration Cards will be inspected at Signing On.

Particular attention should be paid to Regulation S 7.1.5.1 with reference to the need for a RS National licence for certain cars over 1100cc.

1. The Meetings will be held under the General Regulations of the Motorsport UK (incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations and any written instructions the promoting club may issue for the event.
2. The length of the course is 1000 yards and consists of two sharp left-hand corners, one sharp right-hand corner and several fast bends.
3. Attention is drawn to the requirement for a Motorsport UK Logbook or Motorsport UK Recognised Vehicle Identity Document as defined by Regulation S. 9.1.7.
As you are aware, the phasing out of the old- style, Competition Car Logbooks continues with the Latest batch, CCLBs issued between $1^{\text {st }}$ January 2000 and prior to $31^{\text {st }}$ December 2004, having expired at the end of 2022.
The date of issue on Competition Car Logbook can be found on the top right-hand corner of the Front page. However, a good suggestion from a Scrutineer was to advise you of the last CCLB. Number issued during this period, as this is an easy reference to identify the logbook. Our records show that the last CCLB issued prior to $31^{\text {st }}$ December 2004 was no. 26639. So, any CCLB with this number or lower should now have expired.
4. Provisional results will be published as soon as possible after the completion of timed runs. Appeals should be made in accordance with Regulation C. 6.3(f).
5. Competitors will be permitted to enter Wiscombe Park (MR 193/185924) via the Course until 0815. After that time, they will be held in the Top Paddock until it is convenient to send them down the Course.
6. Signing-on, scrutineering and practice will be conducted in Class order.
7. Competitors will be permitted to walk the course and are strongly encouraged to do so but must be clear of the hill by 08:30.
8. Cars will start singly in their own time after the green light is displayed. The method of timing will be electronic on the breaking of beams at the Start and Finish. The finish line will be indicated by a banner. Timing Struts in accordance with Regulation S.10.10 must be fitted before practice or no time will be given.
9. There will be two practice runs at each event followed by two timed runs. If time permits additional runs may be offered but these may not count towards the results
10. Competitors are responsible for providing their own competition numbers, displayed on a contrasting background, as Regulation S. 9.2.5. Drivers of shared cars must ensure appropriate number is displayed for each run.
11. Competitors' attention is specifically drawn to the requirements of Regulation S.9.2.1., particularly with regard to the fitting and wearing of an FIA approved FHR device, if required, in accordance with Regulation K.9/11 and S.9.2.1
12. Competitors running their car on Methanol must indicate this on the Entry Form and must also display an orange disc on their vehicle in accordance with Regulation J. 5.13.6.
13. Cars that can only be started by means of external batteries must be started in the top paddock before descending the hill. Batteries will be provided by the organisers. Crash helmets must be worn at all times when descending the hill, in accordance with Regulations K. 10.1 and S.9.2.1.
14. The use of any external device or power source to preheat the tyres of a competing car, whether the tyres are fitted to the car or not, is prohibited. This does not affect the right of a competitor to spin the wheels to induce heat into the tyres in the area designated for the purpose, but forward motion must be maintained. If, however, a driver is deemed to have deliberately stalled his engine, he may not spin his wheels until he reaches the point at which the stall occurred.
15. Competitors are informed that some information from the Entry Form for these events will be stored in a computer system by the Event/Entries Secretaries for the use of Woolbridge Motor Club Ltd in the administration of Speed events. May we also draw your attention to that some of the Wiscombe Park events may be "livestreamed" to social media (Facebook and YouTube). By entering these events you consent to yourself and your vehicle being broad cast as part of the live footage of the event and in any subsequent re - transmissions.
16. Competitors are reminded that their time will be credited only if all four wheels of the car are on the track when it crosses the finish line, in accordance with Regulation S. 9.5.3.

Furthermore, if a competitor is observed to have all 4 wheels off the track, at any point on the hill, their time will not be credited.
17. The programme of the Meeting will be as follows:

- Signing-on will start at approximately 0730 in the Bottom Paddock
- Scrutineering will start at approximately 0745 and will be conducted in your paddock space.
- Practice will start at approximately 0830
- The first competitive run will be at approximately 1345

18. Any competitor who, because of distance or other genuine reason, finds difficulty in complying with the times above may report at a different time provided that prior permission has been obtained from the Clerk of the Course.

designed for use on the public highway in road legal form. It must have
been manufactured in the required production numbers 1000 per year.
Modified Cars Specialist Production are defined as cars complying with S.13.2,13.3-13.5,13.6.2,13.3-13.9.
Must have been available to the general public and originally designed for use on the public highway in road legal form. It must have been manufactured in the required production numbers 20 per year. Sports Libre Cars must comply with S. 14 and Racing cars with S.15.
Rally Cars must comply with R.46-49 and S.14. Included in the latter Category would be Group B cars, any
cars without the original engine block of the model entered, and car with a transmission layout not as originally specified for that model, or a Specialist Rally Car without an engine complying with S.13.6.2. They need not be taxed.

## Note 4:

The onus of responsibility for the eligibility of vehicles competing in the championship rests with the Entrant/Competitor. In the event of a dispute concerning the compliance of a vehicle to the regulations, the onus will be on the competitor to satisfy the organisers, NOT the organisers to prove compliance.

## Note 6:

Tyre wrapping with single use plastic is not allowed during the events.

## 20. All vehicles must comply with MSUK Regulations as appropriate.

 In addition, particular notice should be taken of Section S in the 2024 Motorsport UK Yearbook.> Competitors' attention is specifically drawn to the requirements of Regulation S.10.1.3 which states: Road-Going Specialist Production, Modified Series Production Cars and Modified Specialist Production Cars must comply with K.1.6.1 or K.1.6.2. and
> Regulation S.10.2.11 which states: Hill Climb Super Sports Cars, Sports Libre Cars and Racing Cars must be equipped with a currently homologated FIA safety harness complying with K.2.1.3 or K.2.1.4.
